

Pamagirri Art Market for Emerging Artists:
Rainforestation Nature Park, Kennedy Highway, Kuranda.



Information for Artists:

You have been invited to hold a stall at the inaugural Pamagirri Art Market for Emerging Artists, hosted at Rainforestation Nature Park, in partnership with Umi Arts.

This event will be held from 10:00am until 1:00pm on **Sunday 22nd November 2020**.

This Art Market is being hosted by The Pamagirri Aboriginal Experience, part of Rainforestation Nature Park, which is owned and operated by the Capta Group. It is the goal of the organisers to provide emerging local artists with an opportunity to sell work and gain experience through interacting with fellow artists and art buyers.

We are proud to be partnering with Umi Arts in this initiative as we feel that our values, in supporting emerging artists are closely aligned.

Organisers Liability:

The Art Market exists to provide a venue whereby interested buyers will be afforded the opportunity to purchase art they might not otherwise have known was available. At the same time, the market exists to provide Artists a platform to make sales that they may otherwise have been unable to realise. The organisers do not enter into the art sale in any way. The sale of any artworks are direct transactions between the participating artists and the buyers themselves.

The organiser will provide a shaded position and a table for the artist to display their wares.

The organisers shall not be liable for any damages of any kind including without limitation, direct, indirect, incidental, punitive and consequential losses (including loss of profits and loss of data) arising out of your participation in this Art Market.

In the event of any disputes between artists and art buyers, the organisers are under no obligation to mediate. We encourage both parties to seek mediation, and where satisfaction cannot be fulfilled, to seek qualified legal information, advice or guidance as appropriate to settle the matter.

Artists acknowledgement and responsibility for works:

In agreeing to participate, you acknowledge and agree that you are solely responsible for all Original Artwork that you make available for sale through the Pamagirri Art Market.

For all Original Art you intend to sell, you warrant that:

1. You are the creator, and sole and exclusive owner of the original Artwork;
2. Nothing you make available at the market will infringe, misappropriate or violate a third party's patent, copyright, trademark, trade secret, moral rights or other intellectual property rights, or rights of publicity or privacy, or result in the violation of any applicable law or regulation without limitation.

3. Further to your acceptance of the terms above, the organisers retain the right to refuse entry to any Artworks that they deem may be:

- offensive, including material that incites racial hatred or promotes discrimination.
- obscene or pornographic
- materials that infringe another party's copyright, patent, trademark, design right or other intellectual property or proprietary right.

Costs of Participation:

There is no fee for artists to participate in the event and there are no commissions to be paid on the sale of your artworks.

The organisers are not in a position to support with expenses related to the transport of yourself or your work to the Art Market. There may also be costs involved in preparing the display of your artworks at the market. Whilst the organisers will work with each artist to ensure the best possible display of their works, they will not be able to assist with any related costs.

Artists Responsibility:

- Verify your identity by providing us with a copy of your ID by way of the application form.
- Write and have ready to display an "Artists Profile" which offers buyers an understanding of your experience and background, as well as some insights into the thinking behind your art.
- Set the retail price of your artwork and be prepared to display that price openly.
- Be able to transact payments with the art buyers on the day. Cash is an acceptable form of payment, but you may wish to consider other electronic means of payment as well. The organisers will not get involved in Art Sales transactions.

Works of Art:

There are no restrictions on the type of Art that can be displayed and sold at the Art Market except that this is an Art Market for Emerging Indigenous Artists;

- The artist is an Indigenous Australian that must be present at the Art Market.
- The works of Art themselves have some connection to the Artists cultural heritage.
- There are no restrictions on the art medium itself.

Notes on Pricing:

Whilst Artists are free to set the price for their artworks, it should be understood that this is an Emerging Artists Market and buyers expectations will be that they can purchase something for their collections that is cheaper than the prices typically seen in Art Galleries from established and signed artists.

Display:

The organisers will prepare a suitable location for the display of the Artists work. Each location will be equipped with one Table and one chair. Based on the information provided in the application form the organisers will also create a short Artists Bio for display at each stand. Any additional signage that the Artists may choose to create to introduce themselves and their work will be at their own discretion and at their own cost.

Any framing, mounts, display screens, easels, technology or fittings required to display the work will also be at the expense of the artist themselves.

Artists will be given access 2 hours prior to the start of the event to set up, and 2 hours after the event to pack up. If additional time is required Artists are required to liaise with the organiser prior to the Art Market.

Promotion and Permission:

We would encourage you to share examples of your Artwork during the application process. By submitting your application, you agree that the organisers can use images of your artwork for promotional purposes.
